A sudden death round will take place for tied matches after three rounds.**

**Finals**

**Women-3 rounds, 2 minutes, 1 minute rest  
Men-3 rounds, 3 minutes, 1 minute rest  
A sudden death round will take place for tied matches after three rounds.**

**Officials:**           **Each representing club will sign in for coach pass at Admission based on number of athletes per club.**

**Referees:**           **Ontario Taekwondo Association (OTA) Referee Chairperson will appoint referees for all qualifying tournaments.**

**Equipment:**       **WTF approved equipment only. All competitors must provide their own protective equipment: head gear, chest protector (newly approved), arm & shin guards, groin cup and mouth guard.**

**Inspection:**       **All competitors must pass the inspection desk before their match. Inspection sheets will be used to confirm proper inspection.**

**Medical:**           **O.T.A. Medical Support Team will be on site to treat injuries and provide taping service - \$5.00/taping.**

**Protest:**           **A written report of the protested match must be prepared by the coach and submitted to the Arbitration Board within 10 minutes of the end of the match, with protest fee of \$200.00 in cash or money order. Protest forms will be available at Head Table.**

**QUALIFYING TOURNAMENT RULES FOR SENIOR DIVISIONS**

**Format of Competition: Please refer to Provincial Point System Tournament Procedures**

**Registration:**

- **Registration Fee and Membership Fee must be paid in full by final deadline, payable to OTA**
- **Late fee will apply, if registration is received after specified deadline date and must be paid in full prior to final deadline**
- **Whether you register for the season or two games or one game, the registration fee-sparring: \$150.00 for season (3 games) or \$120.00 for 2 games or \$60.00 for 1 game, forms: \$150.00 for season (3 games) or \$120.00 for 2 games or \$60.00 for 1 game or, both competitions: \$250.00 for the season (3 games), or \$220.00 for 2 games, or \$100.00 for 1 game. All fees must be paid in full by deadline.**
- **Day of Weigh In Registration, late fee of \$50.00 and must be delivered to OTA O.T.A. Official during Pre-Weigh In Session**
- **There will be a \$20.00 service charge to any NSF cheques**
- **Injury – In order to receive a full refund, a doctor's note must be presented to the O.T.A. Official prior to official Weigh In. If Doctor's Note is presented after weigh in, only half of the fee will be refunded**

**Weigh In:**

- **Weigh in will take place at the specified location on Information Package (pg.4)**
- **Weigh in will be held the day prior to Competition Day, Pre-Weigh In (check weight) will be available one hour prior to Official Weigh In. All changes are closed once Official Weigh In has been declared by O.T.A. Officials.**
- **All registrants must weigh in within the designated weigh in time, or will be disqualified**
- **Weigh in will be conducted by OTA designated officials**
- **Only appropriate gender officials will be performing Weigh In.**

**QUALIFYING TOURNAMENT RULES FOR JUNIOR DIVISIONS**

**Format of Competition**

The purpose of this new format of competition is to encourage games participation for Ontario Junior Athletes to compete regular provincial competitions.

- Two games are scheduled for 2006 Ontario Junior Black Belt Team Selection, Sunday, March 26, 2006 and Sunday, April 23, 2006
- Single Elimination
- Points will be awarded to 1st place, 2nd place and 3rd places  
*1st place 20 points, 2nd place 15 points and 3rd place 5 points*
- A ranking order is established with total points earned for junior athletes that participate In both Game 1 and Game 2-2006 Ontario Junior Black Belt Team Selection, which determines the the 1<sup>st</sup> place, 2<sup>nd</sup> place and two 3<sup>rd</sup> places. The athlete accumulated the highest points after Game 2, will be the champion.
- Points will only be accumulated for those who participate in both games. Points will be transferable if moving divisions.
- There is a one game requirement for those who would like to participate at 2006 Canadian Junior National Taekwondo Championship on June 3 & 4, 2006.
- Top four ranked players at completion of Game 2 will be the supported Ontario Junior Black Belt Team, where they will receive a team outfit and some financial support- TEAM A only. Team B & C will only receive team outfit if they participate at 2006 Canadian National in Saskatoon.

**TIE BREAKER**

**Two Way Tie: The following criteria will be used**

1. Total points earned, on matches between the two players
2. Total points against, on matches between the two players
3. Least number deductions, warning is not accountable
